1. Overview of NSTFDC

National Scheduled Tribes Finance and Development Corporation (NSTFDC) is incorporated as a Govt. Company under the Ministry of Tribal Affairs (MoTA) and granted license under Section 25 of the Companies Act, 1956 (now Section 8 of the Companies Act, 2013). It is managed by the Board of Directors having representation from Central Govt., State Channelizing Agencies, National Bank for Agriculture and Rural Development (NABARD), Industrial Development Bank of India (IDBI) Tribal Co-operative Marketing Development Federation of India Ltd. (TRIFED) and eminent persons representing Scheduled Tribes.

The Corporation plays a leading role in the economic up-liftment of Scheduled Tribes by providing them financial assistance at concessional rates of interest through channelizing agencies for setting up viable income generating project. Financial assistance of NSTFDC is available to only those Scheduled Tribes having annual family income of up to Rs.3,00,000/- p.a. residing both in rural and urban areas.

2. Scope Of Work

The implementation Agency (IA) selected will execute the establishment of “Space Labs” in EMRS which will be entirely funded by CSR donor agencies. **The establishment of these space labs shall mandatorily be executed through ISRO recognized “Space Tutor” organizations only.** The IA will select “Space tutor” agency/s through public tendering, as per the norms prescribed by the donor organization if any. These projects will be funded by CSR donor companies to NSTFDC as a part of their CSR activities.

NSTFDC aims to enhance the quality of education by bridging the educational gaps and open new avenues for tribal youth in the fields of space science, technology, engineering, and math (STEM), through these Space Labs in Eklavya Model Residential School (EMRS) run by National Education Society for Tribal Students (NESTS), a society under Ministry of Tribal Affairs across 26 states and UTs.

Broad Scope of Work includes:

- i To prepare DPR in consultation with NSTFDC to be submitted to the Organization/PSUs funding CSR projects for establishment of “Space Labs”.
- ii To ensure quality and sustainability while implementing the projects through “space tutor” organizations as per mutually agreed time frame along with its monitoring and reporting to NSTFDC;
- iii Procurement of goods and services as required in each project, by ensuring compliance with prescribed norms of **public procurement** through advertisement as in case of Government agencies and/or in mutually agreeable terms with NSTFDC.

- iv To ensure fulfillment of all documentary requirements as prescribed under the Companies Act and relevant Rules and also by donor agencies;
- v To support NSTFDC in reaching out to more CSR donors to meet the cause of tribal people; and
- vi Ensuring publicity/branding in each project to the satisfaction of the donor agencies, which will include creation of short videos, coffee table books, promotional contents etc.

6. Place of Submission of Tender:

The EOI/tender document is required to be submitted in **three separate sealed envelopes**; the Pre-Qualification, Technical & Financial Bids are to be placed in 3 different sealed envelopes and superscribed "Pre-Qualification Bid", "Technical Bid" & "Financial Bid".

All these envelopes may be placed in a larger envelope duly superscribing as “Bid for hiring of “implementation agency for execution of CSR projects” to be opened on **6th August 2025 at 15.00 hrs** in conference room of NSTFDC office.

Bids received without three separate envelope shall be rejected and will not be considered further. The envelope containing the proposal may be sent by Registered Post/ Courier or dropped in the “Tender Box” placed at Regd. Office of NSTFDC and addressed to Ms. Bismita Das, Chief Manager (Proj. & CSR). **Bid will only be opened if more than 1 bid received.**

7. **Selection process:** The Technical Bids of only those bidders will be opened who meet the pre-qualification criteria. The selection will be based on Two Stage QCBS method and the work will be awarded to bidder with the Highest Composite Score.

8. Pre-Qualification Eligibility Criteria

- a. The Agency should be a registered legal entity with at least 5 years standing up to the date of issue of tender notice. **(Please attach copy of incorporation/registration).**
- b. The Agency should have carried out at least three projects in Government Agency/ Deptt./ Public Sector Undertaking/ Autonomous Body under State/ Central Govt./ Academic Institutions of national importance, in the last five financial years; wherein at least one such project should be funded through CSR. **(Please attach the list of credentials and clientele along with their work orders).**
- c. The agency should have experience in executing project in **minimum 08 states** in the country **((Please attach the list of credentials and clientele along with their work orders).**
- d. The Agency should not have been blacklisted during last 3 years by any Department of Government of India or Public Sector Undertaking or any other Govt. Organization. **(Please attach an affidavit of this effect signed by the authorized legal representative of the Agency).**
- e. The Agency should be registered with the GST authority as applicable. **(Please attach copy of registration certificate).**
- f. The Agency should furnish 3 financial years audited financial statement (2021-22, 2022-23 & 2023-24). The average turnover from core activities during the three years of the Agency (Tenderer) should be more than **Rs.10 crores.** **(Please attach audited financial statement)/ CA Certificate.**

- g. The Agency must be registered with ESI, PF/EPF etc. or other statutory bodies (if applicable) as required under various labor laws. **(Please attach documentary proof).**
- h. The Bidder shall be required to deposit Rs. Forty lakhs only (Rs. 40,00,000/-) as Interest free refundable **Earnest Money Deposit (EMD)**. The amount may be paid in the form of Demand Draft/Bankers' Cheque/Bank Guarantee with one year validity **in favour of National Scheduled Tribes Finance & Development Corporation payable at Delhi**. The EMD must be deposited separately in a separate envelope. The EMD should be submitted along with Pre-Qualification Technical Bid. (There will be exemption from MSME from EMD subject to submission of proof of registration).
- i. Self-attested copies of all relevant certificates and documents supporting the information must be furnished with the application along with an affidavit certifying the authenticity of these documents and facts provided.

9. Reasons of rejection:

The proposal will be summarily rejected in case of any of the following;

- The proposal received after the stipulated date and time.
- Open / Stapled / improperly sealed / received through fax/mail.
- The proposal received without EMD & Bid processing fees (unless exempted).
- The agency is registered less than 5 years.
- Conditional Bid submitted by the agency.
- The agency has been blacklisted during last 3 years.

10. Selection Process

Step1: Pre-Qualification of Technical Bid:

The Technical Bid of only those Agencies shall be considered that fulfill all the pre-qualification eligibility criteria and provide required supporting documents **including the EMD and Bid processing fees of Rs. 2360/-**. The EMD shall be refunded to unsuccessful bidders without interest within three months from the date of opening of Tender (Financial Bid).

Step 2: Pre-Bid Meeting:

The Pre-Bid meeting may be held on **1st August at 11.30 am**, if there is change in the date it will be uploaded on the web portal of NSTFDC.

Step 3: Evaluation of Technical Bid:

The Technical Bid shall be opened on **6th August at 15.00 hrs** by a Bid opening committee constituted by NSTFDC for the purpose in presence of the representatives of agencies, who wished to be present during opening of the Bids. The Technical Bids shall be evaluated by the Tender Evaluation Committee. Such committee at its discretion may visit Agencies' office/work place to check infrastructure/relevant documents as available with the Agency. The technical bid will be evaluated as per the criteria specified in this document. NSTFDC have right to ask further clarification/ documents during evaluation of Technical Bid.

Further,

- (i) The goods are to be sourced from ISRO approved merchandiser (space tutors who establish the space labs will have compulsorily to procure everything from these registered merchandisers):<https://www.isro.gov.in/registered-isro-merchandisers.html>
- (ii) Material used should be a combination of Aluminium, PVC and fiber only.
- (iii) The party applying against the tender has to submit the design of the model along with measurements and also declare the material to be used in the technical bid.

Step 4: Evaluation of Financial Bid:

The Financial Bids of only those Agencies shall be opened that have secured minimum 70 marks in technical bid. The **selection will be based on Two Stage QCBS method and the work will be awarded to bidder with the Highest Composite Score.**

Financial Score:

The financial score of the bidder will be calculated with respect to the lowest quote shown against the cost of implementation of the project by any bidder. The lowest cost will be considered as the percentage of the total value of project claimed by the bidder as the cost of implementation and also based on the maximum price shown against each item of goods and services.

Step 5: Final Score:

- a) The Technical bid shall have a weightage of 70% in the overall evaluation of the bid and the financial bid shall have a weightage of 30% in the overall evaluation. The final score of the bidder shall be $0.7 \times (\text{Technical Score}) + 0.3 \times (\text{Financial Score})$.
- b) The bidder with the highest final score shall be eligible for award of the contract.

ACCEPTANCE OF TERMS AND CONDITIONS

- 1) The income tax if applicable, shall be deducted at source unless exempted by the Income Tax Department.
- 2) The timelines for completion of project will be defined separately in each CSR funded projects, the payment terms will be as per the conditions of the donor agencies and will be decided separately for each project.

3) Payment terms and conditions:

The release of funds under the specific project will be made based on the **various milestones of the project** including physical progress and submission of other relevant documents. The payment installments will be as per the norms prescribed by the donor agencies.

The above-mentioned fund release will be subject to the following conditions:

- (i) The above payment schedule is subject to the actual release by the CSR funding agency to NSTFDC – for each particular project.
 - (ii) The successful bidder, on award of each project will submit an Demand Draft/ Fixed Deposit receipt from a commercial bank/ Bank Guarantee (validity of one year) from a commercial bank, equivalent to 3% of the value of each project separately.**
- 4) The successful bidding Agencies shall procure goods and services required in the implementation of CSR projects through public procurement, which will compulsorily include advertisement in at least in one English and one regional language newspaper.
 - 5) Upon completion of the project, the bidder is required to submit necessary reports, promotional material for respective CSR donors etc.
 - 6) These terms and conditions will be applicable for each CSR funded project separately (payment received and work done in any one project cannot be clubbed with another project);
 - 7) Agencies not carrying out the work assigned as per the guidelines shall be warned to complete the work as per the specification. In case the agency still does not comply with the instructions, the work order will be cancelled and any amount paid as advance will be recovered along with interest at prescribed rate. Further, the agency could be blacklisted and no correspondence, in this regard shall be entertained.

The Delhi Courts shall have the sole and exclusive jurisdiction to decide the issue of any dispute.

If at any stage it is found that the firm had not carried out actual implementation of respective projects or submitted false/ forged documents/ information/ photographs to NSTFDC, the organization will be black listed and liable to refund the amount released by NSTFDC with 12% interest per annum.
